Join the Stephen Lewis Foundation at historic HIV/AIDS gathering in Vancouver Media are invited to attend African Grandmothers Tribunal at Chan Centre on September 7

VANCOUVER, BC, September 3, 2013 – Media are invited to join the Stephen Lewis Foundation, front-line African experts, eminent judges Gloria Steinem, Joy Phumaphi, Theo Sowa and Mary-Ellen Turpel-Lafond, and special guests David Suzuki and Stephen Lewis at the first-ever African Grandmothers Tribunal in Vancouver on September 7.
